

REVELLE CONSULTING GROUP's Parent Company Announces Incorporation in Canada

Creating a foundation for the expansion of operations

South of Tokyo, Japan — Today, REVELLE CONSULTING GROUP (RCG) announces that, on October 21, 2025, its parent company, REVELLE MEDIA GROUP INC. (RMG), became a federal corporation under the *Canada Business Corporations Act* (CBCA) of Canada. In taking this action, the goal was to provide a foundation for creating a North American base for RCG's expansion of operations, further extending and building on RMG's current, long-standing corporate communications operations in Japan. It is hoped that this will allow RCG to service hedge fund customers in Canada, the U.S., and elsewhere in new and better ways while leveraging the long history of the RMG's founders in the field of corporate communications/consulting, marketing/branding, and publishing & wordcraft solutions, reaching back to 2009 and before (since the late 90s).
